EXECUTIVE DIRECTOR'S STATEMENT



In 2021 we marked our 50th year of serving our local communities through access to high quality, affordable, and accessible mental health services. Recent years brought heretofore unseen challenges, as we responded to an exponential growth in demand for our services during a public health crisis. Our dedicated and talented staff built a robust telehealth capability to continue care for our clients. With skilled stewardship from our Board of Directors combined with the generous support of our donors we were able to steady our finances and sustain our clinics in Danville and San Ramon when sadly many other community clinics had to close their doors. Already one of the Bay Area's largest and highly regarded training programs for future mental health professionals, we managed in this last year to expand our training opportunities and welcomed the largest class ever to our SCIP program.

In this impact report, we demonstrate our commitment to continue expanding access to mental health services and be dynamic in responding to the evolving needs of our communities. We also highlight The Thrift Station and Friends of Discovery, which is an element of our story that illustrates so beautifully the power of community.

In ways large and small, recent times have challenged many of us to engage in our own metamorphosis of sorts and seek something more meaningful in our lives. SCIP & SPP

(SCIP) School Based Counseling Intervention Program



Discovery Counseling Center's School Based Counseling Intervention Program (SCIP) offers mental health services and support to children, adolescents and teens (grades K-12) in each of the 36 school sites in the San Ramon Valley Unified School District.

The program is staffed by "SCIP Counselors" who are graduate students in either Master's programs or Doctoral programs and who are gaining clinical hours of experience towards graduation or licensure to become Licensed Marriage and Family Therapists (LMFT) or Licensed Clinical Psychologists.

SCIP counselors are supervised by licensed staff therapists of Discovery Counseling Center. Both individual and group therapy is offered at no charge to families.

(SPP) Sports Psychology Program

Through a partnership with JFK University and the San Ramon Valley Unified School District, Discovery Counseling Center launched a new sports psychology program, designed to provide early and effective mental skills and mental health interventions to student athletes at each of the four high schools in the district.



Through individual and group sessions, student athletes are offered the opportunity to address concerns related to their sport performance, pursue mental skills training to improve performance, receive athletic assessments related to their sport, and enhance overall mental health. The opportunity to work through personal concerns through individual counseling is also available, if needed. SPP sessions are conducted by

pre-licensed Discovery Counseling staff under the supervision of licensed mental health and sport psychology professionals.

Schools' athletic directors, counselors, and administrators are incredibly grateful for the increased support and everyone is excited to continue working toward developing this partnership.


